Item 6- Old Business: Land Updates

Item 7- Old Business: Bond Issuance Status

Alan Matslov from GK Baum stated that Bonds will be non-rated because of the Eaton Area Park and Recreation District not having any financial history. Alan stated since the bonds will be non-rated the interest rate will be a higher than rated bonds. He also stated that grants that we can apply for our GOCO, Energy Impact Grant, and grants through DOLA. GK Baum is looking to lock in a rate on the bonds in the next couple of weeks and have a mid June closing date. The bonds will be sold in 500,000 denominations. The bonds will be around 22,600,000 instead of 24,345,000 because of the bonds being non-rated.
